Classes of mobility scooter and powered wheelchair

There are different rules for using your mobility scooter or powered wheelchair, depending on what 'class' it is.

The classes for mobility scooters and powered wheelchairs are:

- class 2
- class 3

Some mobility scooters and powered wheelchairs are not in a class.

The seller or manufacturer can usually tell you the class of your mobility scooter or powered wheelchair. If they cannot, you can check based on its speed, width and weight.

Class 2 and 3

Your mobility scooter or powered wheelchair is usually in:

- class 2 if it has a maximum speed of 4mph or less
- class 3 if it has a maximum speed of 8mph

Mobility scooters and powered wheelchairs in class 2 and 3 can be used:

- on pavements and other pedestrian areas
- on cycle tracks

Class 3 mobility scooters and powered wheelchairs can also be used on the road. You need to register them with DVLA.

Mobility scooters and powered wheelchairs in class 2 and 3 cannot be used on cycle lanes.

Cycle tracks are different from cycle lanes. Cycle tracks are separated from the road by barriers or distance. Cycle lanes are painted on the road and run alongside where usual road traffic (like cars) go.

Not in a class

Your vehicle is not in a class if:

it can go more than 8mph

- it's wider than 0.85 metres
- it weighs more than 150kg (or 200kg if you need any equipment attached to it - for example, medical equipment)

If your mobility scooter or powered wheelchair is not in class, you can only use it on the road.

You cannot use it on:

- pavements or any other pedestrian areas
- cycle tracks or cycle lanes

You need to:

- get a valid driving licence to drive one
- register your vehicle with DVI A

You may also need to insure your vehicle. Check how to <u>insure or</u> register your vehicle.

If you cause an accident while driving a mobility scooter or powered wheelchair that's not in a class, you can be given the same penalty as if you were driving a car. You can go to prison, get a driving ban or get an unlimited fine.

The batteries mainly used in mobility scooters and power chairs are: 22 amp £42.89 26 amp £45.65

35 amp £58.42 45 amp £77.81

50 amp £98.95 55 amp £101.92

75 amp £126.48

The prices change if the USD increases or decreases by 5%



Why do you need to support this?

Supporting Hubs will assist in financially supporting ShopMobilityUK.

We have been very fortunate in that we have recently attracted a three-year grant from the Department for Transport (DfT), which will assist enormously with the underlying costs of running ShopMobility UK. This is as a part of the DfT initiative you may have read about in the press, called the *Hubs Mobility Advice Service*. The idea is that the Hubs (15 of them spread across the country) will refer their users to their local ShopMobility UK scheme, leading to more business for all of us - and in the other direction we will inform all our users, through giving out a small leaflet, of the

initiative and how to contact their local Hub which will provide information, advice, and services in terms of managing personal mobility.

ShopMobility outlets offer a low-cost hire opportunity enabling those with a disability to gain access to not just the high-street, where they constitute an important part of the local economy, but also to other local attractions.

NATIONAL SHOPMOBILITY DAY, 7TH JUNE 2024

The 7^{th of} June is rapidly approaching and to obtain the greatest benefits it is important to ensure preparations are underway well in advance.

I have listed some of the ideas that have been mentioned in the hope that you may be able to use some of them. If you have other ideas, please let Lisa know on Shopmobility@drivingmobility.org.uk as soon as possible.

Arranging to have a display of equipment in a prominent busy location, i.e. town hall, library, major shopping centre etc should be done now as many of these types of places could be in demand. So, a good idea to book well in advance.

Invite local dignitaries to visit, i.e. Mayor, LA Chairman, Social Services Chairman, local well-known personality such as a premier league footballer.

Advise your local media, i.e. newspapers, local radio, BBC, and Commercial, local television NOW so that they can plan what they can help with BEFORE the day. Publicity before is worth ten times more than that after as it may bring people to see what you do.

Offer free use on the day.

Offer training to non-members on the day or when convenient.

Contact Rotary, Lions Club, and other charitable organizations to see if they can help with either personnel or money.

Ask if you can display literature in libraries, LA offices, other public buildings.

Write to local businesses now especially if you are looking for money as budgets are finalised in the early part of the year.

Ask for the money for the 'Dress Down' day that week.

Write to Shops pointing out that ShopMobility brings in considerable revenue (if you know the average spend for your centre work out the possible annual total).

Ask local retailers to attend the event on the day and for them to give discounts to members on purchases.
